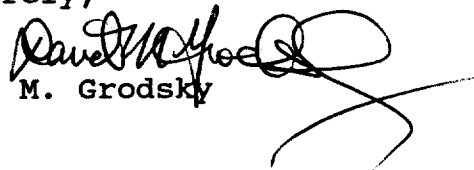
Dear Mr. Wright,

Please find attached the completed FCC Form 442 for approval of an NBC-owned LAN MOB terminal for use by NBC News on the INMARSAT system for voice communications.

As a news organization, it is one of our primary missions to establish reliable and extended voice communications links when conventional means of same are made unavailable. Disruptions to standard means of telephony, either natural or man-made can be surmounted by taking advantage of the INMARSAT system. There may also be situations where such communications must be established in remote areas where no conventional means are available.

NBC News' primary intent in deployment of these terminals is to report on events surrounding above mentioned disasters; secondary use would be for logistical communications in the NBC infrastructure, i.e., coordination of newscoverage resources where alternative communications are not available.
