This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) No WiMAX equipment in the band 3300-3650 MHz will be offered for U.S. sales.
- (3) No equipment shall be developed in the band 3300-3650 MHz since it is a federal government band for radiolocation. Any development needs to be done in an approved FCC band. WiMax should not be developed in the band 3300-3650 MHz for U.S. sales.
- (4) Navini Networks needs to be aware of possible interference from high power government radars in the band 3300-3650 MHz.
- (5) This STA is for equipment that is intended for export only.
