On behalf of Netro Corporation, I am filing its application for an experimental license.

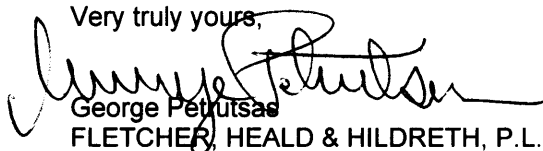
