- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) Operations must be prior coordinated with existing microwave licensees in accordance with 47 CFR, Part 101.103(d).
- (5) Operation is subject to prior coordination with affected existing and future Advanced Wireless Service (AWS) licensees.
- (6) Within 30 days of consummation of the transfer of control, the Applicants shall notify the Chief, Experimental Licensing Branch, of the date of the consummation. The effective date of this authorization is the later of December 22, 2008 or the date of consummation.
