- (1) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.

Special Conditions:

- (3) Licensee must obtain the consent of all affected Location & Monitoring Service licensees (902-928 MHz) within 80 km of the test area.
- (4) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by NASA Langley Research Center contract no. 80Larc17P0026. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (5) Prior to commencing any operations in the frequencies below, the applicant must obtain consent from the following within 50 miles of the contours of the testing area:
>Location & Monitoring Service licensees (902-928 MHz)
- (6) FAA concurrence is limited to proof-of-concept, and is not an endorsement of using 902-928 MHz band for safety-of-life as an experimental licensee. Further development and implementation should seek a frequency band properly allocated for safety-of-life, and Federal usage should be submitted to NTIA for SPS certification by the Federal sponsor.
- (7) DURING TRANSMISSION, AIRCRAFT SHALL NOT EXCEED 100 FEET IN ALTITUDE.
