- (1) Operation in the 1710-1755 or 2110-2155 MHz band requires consent of local Advanced Wireless Service (AWS) licensee(s) to avoid interference.
- (2) Operation in the 824-849 or 869-894 MHz band requires consent of local cellular licensee(s) to avoid interference.
- (3) Operation in the 1850-1910 or 1930-1990 MHz band requires prior frequency coordination with 2 GHz microwave users and consent of PCS licensees to avoid interference.
- (4) Operation is subject to prior coordination with affected Educational Broadband Service/Broadband Radio Service (EBS/BRS) licensees.
- (5) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (6) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (7) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (8) Operation is subject to prior coordination with affected existing and future licensees in the bands 704-710, 734-740, 746-757 and 776-787 MHz.
