This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Special Conditions:

- (1) Licensee must prior coordinate testing with other authorized Band 14 operations. Failure to effectively coordinate shall result in FirstNet seeking immediate suspension of the experimental license by the FCC.
- (2) Licensee must accept interference from others operating in the band and must not cause interference to FirstNet operations or those approved to operate in Band 14 per license (i.e. AT&T testing or public safety entities authorized to operate on Band 14).
- (3) Licensee POC shall submit a "Stop Buzzer" contact to FirstNet at peter.tomczak@firstnet.gov upon authorization issuance with "kill switch" authority; license POC agrees to immediately cease operations on Band 14 if notified of any interference concerns until any issues are resolved.
- (4) Licensee agrees that this license may be subject to further review by the FCC and possible re-coordination with FirstNet.
- (5) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
