APPLICANT CERTIFIES FURTHER THAT:

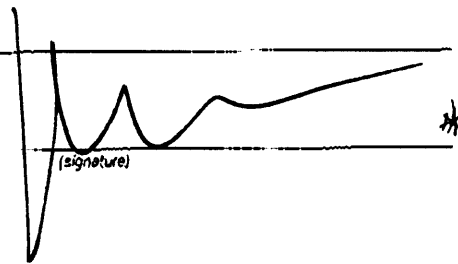
- (c) All the statements in the application and attached exhibits are true, complete and correct to the best of the applicant's knowledge; and
