Northrop Grumman Corporation ("Northrop Grumman"), the Licensee and Transferor, and NNG, Inc, the Transferee, hereby requests Special Temporary Authorization ("STA") to operate the Experimental Radio Service Licenses listed in Exhibit I of the attached FCC Form 703 prior to the Commission's grant of a transfer of control application which is being filed simultaneously with this STA request. Grant of an STA is necessary to ensure continued, uninterrupted operation of these communications facilities which vital to Northrop Grumman's daily operations.

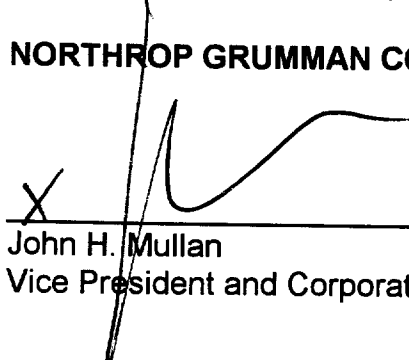
Northrop Grumman's transfer of control application is being filed in light of recent changes in the structure of it's proposed acquisition of Litton Industries Inc. ("Litton") pursuant to the Amended and Restated Agreement and Plan of Merger among Northrop Grumman, Litton, NNG, Inc. and LII Acquisition Corp. On March 23, 2001, immediately prior to the proposed purchase of Litton stock in a tender offer, Northrop Grumman is scheduled to be reorganized, whereby the ultimate control of Northrop Grumman will rest in a new corporate holding company, NNG, Inc.

Due to the recent changes in the structure of the proposed reorganization of Northrop Grumman, complete information regarding the number and types of licenses that would be subject to this transaction only recently became available. As a result, Northrop Grumman was not able to finalize the applications for permanent transfer of control of the all licenses subject to the merger agreement so that such applications could be filed and granted prior to the anticipated closure date of March 23, 2001. Accordingly, Northrop Grumman requests an Emergency STA to close on the transaction on or before **March 23, 2001** and to operate the facilities pursuant to the technical and operational parameters set forth in the licenses for a period of up to 180 days or until the transfer of control application is granted.

Expeditious grant of the STA is in the public interest as it would permit the Parties to close on the transaction as anticipated and would allow Northrop Grumman to ensure continued and necessary operation of these communications facilities pending FCC action on the transfer application.

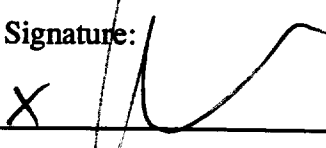
