- (1) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (2) Operation is subject to prior coordination with the United States Navy, Pascagoula Ship Yard, Mr. Chuck Bardsley at (228) 769-4700.

Special Conditions:

- (3) Subject to coordination with the Gulf Area Frequency Coordinator located at Eglin AFB, Florida, prior to use within the area bounded by 24 N 33 30'N and 83 W 90 W.
- (4) Licensee should be aware that United States Coast Guard, Navy, Air Force and Army operations may be assigned to these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (5) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by US Coast Guard contract DTG23-02-C-2DW001. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (6) NTIA denies the following frequencies since they will cause interference to Federal operations or pose interference to flight safety: 140.475 MHz, 1030 MHz and 1090 MHz.
- (7) One of the stop buzzer point-of-contacts, Bruce Cook cell (228) 366-6153 or Joe James cell (228) 366-6226, must be present during all testing.
- (8) Use of the frequency 16529.4 kHz is only allowed after coordination with the Navy Pascagoula Ship Yard, Chuck Bardsley, (228) 769-4700.
- (9) Use of wideband emissions (16K0F3E) in the bands 138-144 MHz, 162-174 MHz or 406-420 MHz do not meet NTIA allowed emissions and may have been denied when GMF authorization was requested.
