Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (3) Scheduling with Western Area Frequency Coordinator, Steve Tosen, (805) 989-7883, is required 48 hours in advance of the use of the frequency 1378 MHz.
- (4) Northrop Grumman and the DoD JPO shall continue to work through the IRAC/SPS to get JTRS approved for the waveform and frequency band being tested.
- (5) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the US Government contract number FA8709-04-C-0011. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (6) This frequency assignment on 1378 MHz was coordinated prior to authorization with the FAA Western Coordinator, Los Angeles, California. Use of this frequency under the authority of this assignment is subject to such further coordination with the FAA Western Coordinator, Los Angeles, California, as necessary to ensure compatibility with existing uses.
- (7) Pulse Repetition Rate: 134 pulses per second.
