- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.

Special Conditions:

- (3) Northrop Grumman Systems Corporation must coordinate with the Western Area Frequency Coordinator (WAFC), Mr. J. Szelog at (760) 939-6948 prior to any California operations to mitigate harmful interference to Navy and Marine Corps assignments. Northrop Grumman Systems Corporation must also comply with any and all restrictions that may be levied by WAFC.
- (4) Upon notification from the FCC, operation on 15.15-15.35 GHz at Red Bluff and San Diego, CA is subject to immediate cessation, if it causes harmful interference to Navy and Marine Corps operations assignments.
- (5) OPERATIONS AT HOLLOMAN AFB, AND WHITE SANDS MISSILE RANGE (WSMR), MUST BE SCHEDULED AS BASE/RANGE MISSION, THROUGH THE DOD SPONSOR. TRAINING OPS AT HOLLOMAN AFB, THROUGH AIR EDUCATION AND TRAINING COMMAND, MUST BE SCHEDULED THROUGH THE HOLLOMAN AFB SCHEDULING OFFICE. TEST OPS AT HOLLOMAN AFB, THROUGH THE AIR FORCE MATERIAL COMMAND, 704TH TEST GROUP, MUST BE SCHEDULED THROUGH THE 586FLTS DET 1. FINAL AUTHORIZATION TO RADIATE IS CONTINGENT UPON SUCCESSFUL SCHEDULING, AND DE-CONFLICTION, OF BOTH AIRSPACE AND SPECTRUM, WITH OTHER AREA OPS BY THE WSMR SPECTRUM MANAGER, WHO MAY IMPOSE ADDITIONAL CONSTRAINTS.
- (6) DURING TRANSMISSION, AIRCRAFT SHALL NOT EXCEED THE ALTITUDE 50,000 FT AGL.
