Special Conditions:

- (1) Subject to coordination with the Area Frequency Coordinator located at White Sands Missile Range, New Mexico, prior to use in the State of New Mexico or other U. S. Territory within a 150 mile radius of WSMR plus the area of Utah and Colorado that lies South of 41 degrees North and between 108 degrees and 111 degrees West. Phone: 505-678-5417 or 3702.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (4) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by Department of Defense contract no. W15P7T-10-D-D408-KZ01. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (5) Operations must be scheduled as a WSMR range mission through the 586flts Det 1, who is the test liaison between Holloman AFB and WSMR. Final authorization to radiate is contingent upon successful scheduling and deconfliction of both spectrum and airspace, with other area wide operations.
- (6) Testing is within Eglin AFB controlled airspace areas R2914 and R2915, the Tindall AFB areas, and the off-shore warning area W151 at Eglin.
- (7) Renewal
- (8) DURING TRANSMISSION, AIRCRAFT SHALL NOT EXCEED THE ALTITUDE 50,000 FEET MSL.
- (9) OPERATION ON THIS ASSIGNMENT IS SUBJECT TO IMMEDIATE CESSATION, IF IT CAUSES HARMFUL INTERFERENCE TO FEDERAL OPERATION.
