- (5) This frequency assignment in the band 2360 to 2390 MHz was coordinated prior to authorization with the Area Frequency Coordinator, Ft. Huachuca, Arizona, who also coordinated it, as appropriate, with the Aerospace and Flight Test Radio Coordinating Council. Use of this frequency under the authority of this assignment is subject to such further coordination with the AFC, Ft. Huachuca, as necessary to ensure compatibility with existing uses.
- (6) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by US Air Force contract number F19628-00-C-0100. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
