Special Conditions:

- (1) Assignment on 1030 MHz or in one of the bands 1215-1400, 2700-2900, or 9000-9200 MHz was coordinated prior to authorization with the FAA Eastern Coordinator, New York, NY. Use of frequencies under the authority of this assignment is subject to such further coordination with the FAA Eastern Coordinator, New York, NY, as necessary to ensure compatibility with existing uses.
- (2) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.

Special Conditions:

- (4) Operation on 1030 MHz at location 2 is authorized only for pulse repetition rate of 235 pps in SIF Mode only.
Operation on 1030 MHz at location 3 is authorized only for pulse repetition rate of 235 pps in Modes 1, 2, 3A and C only.
- (5) Transmission direction is between -45 and +45 degrees referenced to True North for operations on 2700 and 2845 MHz for Location 1; 1030, 2700 and 2845-2880 MHz for Location 2; and 1030 and 2845-2880 MHz for Location 3.
