- (1) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Use of the frequency 1030 MHz shall be limited to the following:

Pulse Repetition Rates shall be 250 pps and 275 pps.
Pulse Duration shall be 0.8 usecs.

Special Conditions:

- (4) Use of the frequency 3000 MHz (200 MHz bandwidth giving 2900-3100 MHz) shall be limited to the following:

Pulse Repetition Rates shall be 250 pps, 275 pps, 300 pps, 650 pps, 800 pps, 825 pps, 950 pps and 1010 pps.

Pulse Durations shall be 15 usecs, 22.5 usecs, 27 usecs, 28.5 usecs, 90 usecs, 102 usecs, 245 usecs and 257 usecs.

- (5) This assignment on 1030 MHz and in the band 2900-3100 MHz was coordinated prior to authorization with the FAA Eastern Coordinator, New York, NY. Use of these frequencies under the authority of this assignment is subject to such further coordination with the FAA Eastern Coordinator, New York, NY, as necessary to ensure compatibility with existing uses.
- (6) Licensee should be aware that US Coast Guard NAVAIDS may be licensed in the band 2900-3100 MHz, and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
