Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) Coordinate with the existing users in 71-76 GHz band prior to accessing to 72 GHz and 73 GHz.
- (4) Coordinate with the Fixed Microwave Service licensees prior to accessing to 28 GHz, 33 GHz, 38 GHz and 27.5-28.5 GHz bands.

- (6) NYU Polytechnic School need to be aware that there are numerous short range microwave links in and around New York City in the 67-77 GHz band.
