- Applicant certifies that it has verified with reasonable supporting detail no current potential for interference with FirstNet operations or those approved to operate in Band 14 per STA/EL or license (i.e. SMLA licensees/current incumbents).
- POC is established and sent to FirstNet upon STA approval with "kill switch" authority; Applicant agrees to cease operations at request of FirstNet immediately upon receipt of request to kill switch POC until such time, as determined by FirstNet, that project may continue.
