This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) Oceus Networks must secure consents from the Advance Wireless Service licensees prior to operation in 1710-1785 MHz and 1915-1920 MHz bands.
- (4) Prior to commencing any operations in the frequencies below, the applicant must obtain consent from the following within 50 miles of the contours of the testing area:
 - > 700 MHz Lower Band "B" block licensees (704-710 MHz/734-740 MHz)
 - > 700 MHz Lower Band "C" block licensees (710-716 MHz/740-746 MHz)
 - > 700 MHz Lower Band "D" block licensees (716-722 MHz)
 - > Cellular licensees (824-849 MHz/869-894 MHz)
 - > Broadband PCS licensees (1850-1910 MHz/1930-1990 MHz)

- (6) The following conditions apply to Oceus Networks operation at Camp Lejeune, NC during the period 8 July 2019 thru 20 July 2019.

 - > Oceus Networks may not operate in 1805 - 1880 MHz or the 1850 - 1920 MHz bands due to ongoing sensitive law enforcement operations.
