- (5) Licensee is required to file a PROGRESS REPORT every 6 months from the date of grant. This progress report shall be filed with Federal Communications Commission; Experimental Licensing Branch, MS 1300E1; 445 12 Street, S.W.; Washington, DC 20554.
- (6) These frequencies are for experimental purposes only and may not be available for future permanent use.
