- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) Licensee must prior coordinate with existing licensees in the area.
- (4) Licensee must be made aware that the band, 614-698 MHz, is in the 600 MHz Band to be licensed in the Commission's current auction proceedings. As a result, licensee is required to notify the 600 MHz winning bidder(s) of channel blocks F and G in PEA 5 of its experimental license by May 1, 2017. Once the 600 MHz license is granted for channel blocks F and G in PEA 5, licensee must coordinate the use of its experimental license with the new 600 MHz licensee(s). This license authorization can potentially be impacted as a result of the proceedings and licensee is advised to use another band for long term operation
