Dear Mr. Wright:

Pursuant to Condition 3 of Station KM2XEN's experimental license, which was granted on August 10, 1992, and renewed on July 1, 1994, this constitutes the twelfth of our quarterly reports regarding the progress of the authorized experimental PCS operations.

In the time since our last report, Paramount Wireless Limited Partnership (PWLP) has continued conducting PCS analytical studies and experiments pertinent to the commercial implementation of PCS on a large scale basis. PWLP is continuing dialogues with numerous hardware and software equipment vendors pertinent to PCS service implementation, maintenance, management, migration, portability, and personalization.

Our continued studies and experiments include the following:

1. Continued research pertinent to 2 GHz PCS implementation including PCS network architectures and service schedules
2. Preparation of patent applications
3. Financial modeling based on Local Exchange Carrier (LEC) "unbundled" blind assumptions
4. Formation of entrepreneurial company to hopefully participate in "Designated Entity" PCS auctions
5. High level discussions with Regional Bell Operating Company (RBOC) in relation to future testing, etc.
6. Continued dialogue with equipment vendors under non-disclosure agreements.
7. Studying "competition in the local exchange".

The knowledge acquired from the described studies and experiments contributes to what PWLP believes to be a unique vision of PCS as it applies to "competition in

the local exchange" from both a wireless and wireline perspective. PWLP has conducted research on PCS and "competition in the local exchange" concurrently and has developed important insights to the inter-relations of these catalysts of industry restructure. The most important insights are that these two catalysts are working toward the same end and that PCS cannot exist without "competition in the local exchange".

We believe that the unbundling of the local exchange network plays a major role in determining the level of competition in both wireless and wireline telecommunications. PWLP is closely studying the movement of the telephone industry towards a competitive local exchange and is trying to determine the level of competition that PCS network and service providers will enjoy pertinent to the providing of Intelligent Network services.

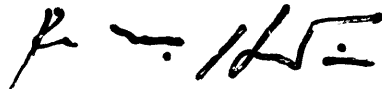
