- (2) Playas Training and Research Center (PTRC) must coordinate operations with the White Sands Missile Range (WSMR) DoD-AFC, in order to schedule their operations in the Integrated Frequency De-confliction System (IFDS). Coordination must be done at least 24 hours in advance. PTRC must provide dates/times of operation, frequency(ies) to be used, output power, and emission bandwidth, as well as provide a copy of the final FCC license to:
