This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. - (4) Prior to operation, licensee must successfully coordinate with all of the existing registered links in 71-76 GHz and 81-86 GHz bands in each proposed location.
- (5) The emissions must be maintained within, and shall not extend beyond, the frequency band limits.
- (6) PointView Tech LLC shall comply with the limits of unwanted emission recommendations specified in Resolution 750 (Rev. WRC-19)
