- (4) Maintain operation separation from the grandfathered earth stations as defined in Part 90, sub-part Z, or coordinate an agreement with the grandfathered earth station licensees prior to operation in 3650-3700 MHz band.
- (5) Consult the ULS database to ensure that the operation will not cause harmful interference to any existing registered stations in the 3650-3700 MHz, and notify the registered users in the proposed area.
