Special Conditions:

- (4) Operations in the 12.2-12.7 GHz band was obtained based on the written consent from DirecTV/AT&T, EchoStar and DISH Network with the following conditions:
 - (a) Maximum transmit E.I.R.P. is -14 dBW.
 - (b) The fixed transmitter location is in latitude 32 54 13.2; longitude 117 11 47.1.
 - (c) Antenna pointing is limited to elevation angle at 2.5 degrees and azimuth 172.8 degrees.
 - (d) Transmitter height (above ground level) 60 feet.
 - (e) Waveform type is limited to continuous wave (CW).
 - (f) Maximum period of operation is 6 months from the date the grant is issue.
 - (g) Link operation activity (typically) from Monday to Friday, 8:00 am to 6 pm PST with a duration of 20 minutes repeated 6 times daily.
 - (i) Frequency of operation consistent with Direct Broadcast Satellite (DBS) guard bands.
 - (j) Antenna pattern as describe in File No. 0772-EX-ST-2017, exhibit document.
