- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Stop Buzzer: Jim Hendershot at 541-226-6101, who can cease transmissions immediately at any given time should interference occur.
- (4) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by Space & Missile Defense Command contract W9113M-04-C-0122. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (5) The frequency bands 2310-2320 and 2345-2390 MHz was coordinated prior to its authorization with AFMO CONUS, Ft. Sam Houston, Texas, who also coordinated it, as appropriate, with the Aerospace and Flight Test Radio Coordinating Council. Use of this frequency under the authority of this assignment is subject to such further coordination with AFMO CONUS, Ft. Sam Houston, Texas, as necessary to ensure compatibility with existing uses.
