- (5) Operation in the 824-849 or 869-894 MHz band requires consent of local cellular licensee(s) to avoid interference.
- (6) Operation is subject to prior coordination with existing and future Educational Broadband Service/Broadband Radio Service (EBS/BRS) licensees.
- (7) Operation is subject to prior coordination with existing and future Advanced Wireless Service (AWS) licensees.
- (8) Operation requires consent of existing and future Specialized Mobile Radio Service (SMRS) licensees.
