Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) One or more frequency assignments were coordinated prior to authorization with FAA Headquarters, 800 Independence Avenue, S.W., Washington, DC 20591; Telephone: 202-267-8699.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) The stop buzzer POC is Jim Ortega at (520) 794-0227.
- (5) Transmissions using a frequency of 1387 MHz shall not be used for airborne operations, as airborne emissions in the 1390-1400 MHz frequency band are prohibiting in accordance with Footnote US79.
- (6) Further requests for extension of the authority granted herein must be filed on Form 442, "Application for New or Modified Radio Station Authorization under Part 5 of FCC Rules - Experimental Radio Service." Future STA requests to extend this authorization will not be considered.
- (7) Raytheon Company (Missiles and Defense - M) shall comply with the limits of unwanted emission recommendations specified in ITU Resolution 750 (Rev. WRC-19).
