Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee is required to coordinate operations with existing microwave users in the area to avoid interference.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) The station identification requirements of Section 5.115 of the Commission's Rules are waived.

Special Conditions:

- (5) Raytheon IIS must contact the Navy and Marine Corps Spectrum Center (NMSC) SATCOM representative; Mr. Richard Ontiveros (richard.ontiveros1@navy.mil) or Mr. Keith Jones (keith.k.jones@navy.mil) prior to scheduled testing events to confirm stop buzzer POC and to mitigate any potential interference that may occur.
- (6) INMARSAT 5F2 satellite @ 55 degrees W.L. (U. K. licensed)
The fixed earth stations are authorized to conduct tests via INMARSAT 5F2 at 55° WL satellite in the 29-30 GHz band.
- (7) Communications between authorized fixed earth station(s) and the INMARSAT 5F2 Ka-Band geostationary space stations must be in compliance with all existing and future space station coordination agreements reached between the United Kingdom and other administrations, and between the INMARSAT 5F2 operators and, if any, the Ka-band NGSO (non- geostationary space stations) operators.
- (8) Experimental station shall use the minimum power level necessary to establish communications links to minimize potential interference to licensed users.
