Special Conditions:

- (3) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (4) Coordination for use of the frequencies must be enacted with DoD AFC AZ at least 14 days in advance of intended use; however, due to airborne radar use within line-of-sight of TUCSON AZ authorization from DoD AFC AZ is not assured and will be based on the scheduled use of the radar assets.
