Szelog at (760) 939-6948 prior to operations at Mojave Airport, CA,, Pt Loma, CA and San Nicolas Island, CA to mitigate harmful interference to Navy and Marine Corps assignments. Raytheon must also comply with any and all restrictions that may be levied by WAFC.

- (6) Operation must not exceed 10,000 ft AGL.
