- (5) Raytheon Network Centric Systems, shall post signs on doors to the test area notifying that, "GPS re-radiator is in use and the GPS information you receive may be in error."
- (6) The test equipment shall only be used indoors and shall be under the control of Raytheon Network Centric Systems.
- (7) Operation is limited to activity for the purpose of testing radionavigation satellite service (RNSS) equipment and systems.
