- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.

Special Conditions:

- (4) The band 1750-1850 MHz is primary federal spectrum and any use of this band should support federal government contracts or foreign sales.
- (5) The designated point-of-contact to terminate transmissions if interference occurs is Mr. John Adams, cellular number: (714) 262-5019 or Office: (803) 318-0021.
- (6) Licensee should get consent from existing and future Advance Wireless Services licensees in the 1750-1755 MHz band.
- (7) Operation in the frequency band 1755 MHz-1850 MHz is subject to immediate adjustment, including cessation, if they results in harmful interference to the military assignments.
