Special Conditions:

- (1) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) Operation is subject to prior coordination with the Fixed Microwave Service licensees in accordance with CFR 47, Part 101.103(d) in 880-940 MHz band.

Special Conditions:

- (5) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government; contract number FA8650-15-C-7534. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (6) Operation is subject to consent of the following within 50 miles of the test area:
 - a) Commercial Air-Ground licensee (894-896 MHz)
 - b) SMR licensees (896-901 MHz/935-940 MHz)
 - c) Location & Monitoring Service licensees (902-928 MHz).
- (7) Operation must be consented by all of Paging licensees in the bands 929 MHz and 931 MHz within 50 miles of the test area.
