- (4) Operation on frequency assignments in one of the bands 1435-1535 or 2310-2390 MHz was coordinated prior to authorization with the Western Area Frequency Coordinator (WAFC), Point Mugu, CA, who also coordinated it, as appropriate, with the Aerospace and Flight Test Radio Coordinating Council. Use of this frequency under the authority of this assignment is subject to such further coordination with the WAFC as necessary to ensure compatibility with existing uses.
- (5) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (6) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (7) No operation is permitted in frequency (w/27 MHz bandwidth):

- (8) No operation is permitted in frequencies (in GHz w/27 MHz bandwidth):

- (9) Operation is subject to prior coordination with fixed microwave service (Part 101) licensees in the following bands:

 - 12.2-12.75 GHz
 - 24.25-24.45 GHz
 - 25.05-25.25 GHz
 - 27.5-29.5 GHz

- (10) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government contract number N00019-05-G-0008 and N68936-05-D-0033. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (11) No operation is permitted in frequency band 2200-2290 MHz.
