- (3) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (4) Operation is subject to prior coordination with the local Society of Broadcast Engineers, Inc. (SBE) frequency coordinator. Consult the list at http://freq.sbe.org/pdf_files/coordinators.pdf to find the appropriate coordinator.
- (5) Raytheon SAS coordinate with the local Society of Broadcast Engineers frequency coordinator prior to operation on 158.45 MHz and 173.2 MHz.
- (6) Operation is subject to notification of the following within 50 miles of the test area:
 - All services in 220 MHz,
 - 220-222 MHz Service,
 - Paging Service licensees in 43 MHz, 158 MHz, and 152 MHz/158 MHz.
