- (5) Raytheon SAS coordinate with the local Society of Broadcast Engineers frequency coordinator prior to operation on 454.5 MHz, 455 MHz, 480 MHz, 500 MHz, and 510 MHz.
- (6) Operation is subject to consent of the following within 50 miles of the test area:
 - Paging Service licensees in 454 MHz/459 MHz,
 - General Aviation Air-Ground Service in 454 MHz/459 MHz.
- (7) Operation is not permitted in 407 MHz.
