- (2) Operation in the 1695-1780 MHz, 1915-1920 MHz, 1995-2020 MHz or 2110-2200 MHz band requires consent of local Advanced Wireless Service (AWS) licensee(s) to avoid interference.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (5) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.

Special Conditions:

- (7) The licensee must consult the ULS database to ensure that the proposed operation will not cause adverse effect to any existing registered stations in the 3650-3700 MHz band and notify registered users in the immediate geographic area.
