- (1) Assignment in frequency bands 960-1400, 2700-2900, or 9000-9200 MHz was coordinated prior to authorization with the FAA Western Coordinator, Los Angeles, CA. Use of frequencies under the authority of this assignment is subject to such further coordination with the FAA Western Coordinator, Los Angeles, CA, as necessary to ensure compatibility with existing uses.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) The 1380 MHz Pulse Repetition Rate: 1-1000 pps.
- (5) Raytheon SAS must coordinate with the Western Area Frequency Coordinator (WAFC), Mr. J. Heaton at (760) 939-6948 prior to any operations to mitigate any possible harmful interference to Navy and Marine Corps assignments. Raytheon SAS must also comply with any and all restrictions that may be levied by WAFC.
