This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. - (3) Raytheon SAS shall coordinate all transmissions with the NASA JPL Spectrum Management Office POC Feiming Morgan at 818.354.9251, Feiming.morgan@jpl.nasa.gov, in order to prevent mutual interference and potential equipment damage resulting from the requested operations and the operations of the NASA Goldstone Solar System Radar (GSSR) in Pasadena, CA.
- (4) Raytheon must not operate in the Las Vegas And Downers Grove area; due to possible interference with critical federal communications operations
