- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (5) Raytheon SAS coordinate with the local Society of Broadcast Engineers frequency coordinator prior to operation on 158.45 MHz.
- (6) Prior to commencing testing operations, the applicant must obtain consent from the following within 300 miles of the contours of the testing area:

 - Paging Service licensees in 158 MHz
 - Paging Service licensees in 152 MHz/158 MHz
 - 220-222 MHz Service licensees
