- (5) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.

Use of frequencies under the authority of this assignment is subject to such further coordination with the FAA Western Coordinator, Los Angeles, CA, as necessary to ensure compatibility with existing uses.
- (14) The transmission is LIMITED to antenna height of no more than 10 ft AGL, and the direction of 237 degrees referenced to True North and at 70 nsec per pulse.
- (15) This license SUPERSEDES the previously issued license with the same call sign and file number: removal of Special Conditions (2).
