- (6) Licensee must coordinate with Fixed Point to Point and Multiple Address System licensees.
- (7) Licensee should get consent from existing and future Advance Wireless Services licensees in the geographic area where the tests are being conducted.
- (8) Operation is NOT permitted on the spot frequencies 118.875 MHz and 119.25 MHz in all other areas.
- (9) No operation is permitted in D-Block public safety bands 758-769 MHz and 788-799 MHz.
