- (2) Subject to coordination with the Western Area Frequency Coordinator located at the Naval Air Warfare Center, Weapons Division, China Lake, CA, prior to use within a 322 kilometer radius of Pt. Mugu or in California south of Latitude 37 30' North at (760) 939-6948.

- (3) Subject to local coordination with Frequency Manager, AFFTC, Edwards AFB, California at (661) 277-4763.
- (4) Subject to coordination with the Gulf Area Frequency Coordinator located at Eglin AFB, Florida, prior to use within the area bounded by 24 N 33 30'N and 83 W 90 W at (850) 882-4416.
- (5) Licensee should be aware that US Navy operations at the Edwards AFB location are assigned co-channel on this frequency or adjacent channel to this frequency, and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (6) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by USAF contract FA8002-02-C-0397. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
