- (5) The Air Force non-concurs with 430.92-436.92 MHz due to non-compliance with G2. The Air Force non-concurs with 2449-2451 MHz.
- (6) Further requests for extension of the authority granted herein must be filed on Form 442, "Application for New or Modified Radio Station Authorization under Part 5 of FCC Rules - Experimental Radio Service." Future STA requests to extend this authorization will not be considered.
