This Special Temporary Authorization is granted upon the express condition that it may be terminated by the Commission at any time without advance notice or hearing if in its discretion the need for such action arises. Nothing contained herein shall be construed as a finding by the Commission that the authority herein granted is or will be in the public interest beyond the express terms hereof.

This Special Temporary Authorization shall not vest in the grantee any right to operate the station nor any right in the use of the frequencies designated in the authorization beyond the term hereof, nor in any other manner than authorized herein. Neither the authorization nor the right granted hereunder shall be assigned or otherwise transferred in violation of the Communications Act of 1934. This authorization is subject to the right of use of control the Government of the United States conferred by Section 706 of the Communications Act of 1934.

Special Conditions:

- (1) Operation on frequency assignments in one of the bands 1435-1535 or 2310-2390 MHz was coordinated prior to authorization with the Western Area Frequency Coordinator (WAFC), Point Mugu, CA, who also coordinated it, as appropriate, with the Aerospace and Flight Test Radio Coordinating Council. Use of this frequency under the authority of this assignment is subject to such further coordination with the WAFC as necessary to ensure compatibility with existing uses.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.

- (4) RF Film, INC must coordinates with the Western Area Frequency Coordinator (WAFC), Mr. J. Szelog at (760) 939-6948 prior to any California operations to mitigate harmful interference to Navy and Marine Corps operations. The RF Film, INC must also comply with any and all restrictions that may be levied by the WAFC.
- (5) This license SUPERSEDES the previously issued license with the same call sign and file number: coordination with WAFC.
