- (3) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (4) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government contract number H92254-16-C-0001. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (5) Operation is subject to "consent" of Lower 700 MHz "B" and "C" licensees (704-716 MHz / 734-746 MHz) within 50 miles of the test area.
