- (4) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (5) Prior to commencing any operations in the frequencies below, the licensee must obtain consent from the following within 50 miles of the contours of the testing area:
 - Location & Monitoring Service licensees (902-928 MHz)
- (6) Further requests for extension of the authority granted herein must be filed on Form 442, "Application for New or Modified Radio Station Authorization under Part 5 of FCC Rules - Experimental Radio Service." Future STA requests to extend this authorization will not be considered.
