Special Conditions:

- (1) Operation in the 1695-1780 MHz, 1915-1920 MHz, 1995-2020 MHz or 2110-2200 MHz band requires consent of local Advanced Wireless Service (AWS) licensee(s) to avoid interference.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) Further requests for extension of the authority granted herein must be filed on Form 442, "Application for New or Modified Radio Station Authorization under Part 5 of FCC Rules - Experimental Radio Service." Future STA requests to extend this authorization will not be considered
- (5) Obtain consents from the Educational Broadband Service and the Broadband Radio Service licensees prior to operation in 2500-2570 MHz and 2620-2690 MHz bands.
- (6) Coordinate with the local Society of Broadcast Engineers frequency coordinator prior to operation in 2400-2483.5 MHz band.
- (7) Coordinate with the affected Fixed Microwave Service licensees prior to operation in 2400-2483.5 MHz band.
- (8) Experimental station shall use the minimum power level necessary to establish communications links to minimize potential interference to licensed users.
- (9) Operation is not permitted in 1850-1910 MHz and 5610-5620 MHz bands.
- (10) The licensee must obtain consent from the following within 50 miles of the contours of the testing area:
 - 700 MHz Lower Band licensees (698-746 MHz)
 - Cellular licensees (824-849 MHz/869-894 MHz)
 - Broadband PCS licensees (1850-1910 MHz/1930-1990 MHz)
